

SKATE RENTAL INFORMATION, RULES & CONDITIONS

- Parents please do not enter the skating surface without skates. No walking on the ice in socks, shoes, or bare feet.
- Parents please do not allow your children to play with the decorations or props
- Skates are in Men's Sizes – Females and children subtract one size from your regular shoe size.
- Please do not bang the skate blades together.
- Only wear skates in designated areas and NOT on the asphalt.
- Please be careful, ice skates are sharp!

RELEASE, INDEMNIFICATION & HOLD HARMLESS

The undersigned participant/parent or legal guardian recognizes and acknowledges that certain inherent hazards and risks are connected with skating, ice skates and being on or near the artificial skating surface. The undersigned further acknowledges that the inherent risks and hazards of skating on or being on or near the artificial surface are as great as or greater than those associated with natural ice. The undersigned hereby knowingly and voluntarily assumes full responsibility for all risks and hazards associated with skating, the skates and being on or near the skating surface whether or not he or she is actually engaged in the act of skating. The undersigned represents that he or she is physically, mentally, and emotionally fit and capable of safely participating in the physical activities associated with skating. As a condition of being allowed to skate, rent skates and/or be on or near the skating surface, the undersigned releases Meridian Marketing & Media, Inc. d/b/a Blue Sky Mobile Media, Taylorsville Apple Festival, Inc., Taylorsville Savings Bank and their employees, officers, directors, volunteers, agents, representatives, affiliates, and related entities (collectively, "Releasee") from and against any and all claims, demands, losses, damages or liability whatsoever, including, but not limited to, any and all personal injuries (including death), property damage or other injuries whatsoever. The undersigned agrees to defend, indemnify and hold harmless Releasee for any and all claims, demands, losses, damages, attorneys' fees, expenses and any other liability whatsoever incurred by or threatened against Releasee as a result of the undersigned's use or misuse of the skating surface, any related equipment, including but not limited to, skates, and the undersigned's presence on or near the skating surface. If the participant is under 18 years of age, the undersigned parent or legal guardian represents that (1) he or she is the participant's parent or legal guardian, (2) he or she has the legal authority to and does hereby sign this document for and on behalf of the participant, (3) he or she has discussed and explained the inherent risks and dangers of the activity with the participant and (4) he or she and the participant are obligated under the terms of this document as evidenced by their below signatures.
